
On February 18, 2000 - more than a year ago - I sent you a letter asking you to send all of our funds (Greta's and mine) to J. Howard Coale, Connecticut Capital, 44 Signal Road, Stamford, Connecticut, 06902. This letter was followed up for by a series of letters. In the course of time, and to suspend the release of funds in the February 18, 2000 letter, you suggested a partnership that was never formally completed. At all times, I assumed the funds were safe and accessible. I would never have agreed to anything absent the funds been safe and accessible.

I have now learned that there is a "problem" with the funds and that various members of the fund have asked for their money. I would like our money as well. In terms of the order of payout, I would like our request to be the first since our request went in more than a year ago (February 18, 2000.) Obviously any suspension in my request since that time was due to the incomplete data - created by your statements - that the funds were safe and accessible. I would not have delayed our request for our money beyond February 18, 2000 if it were not for your assurances all was well.
